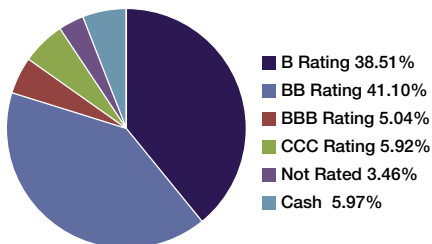

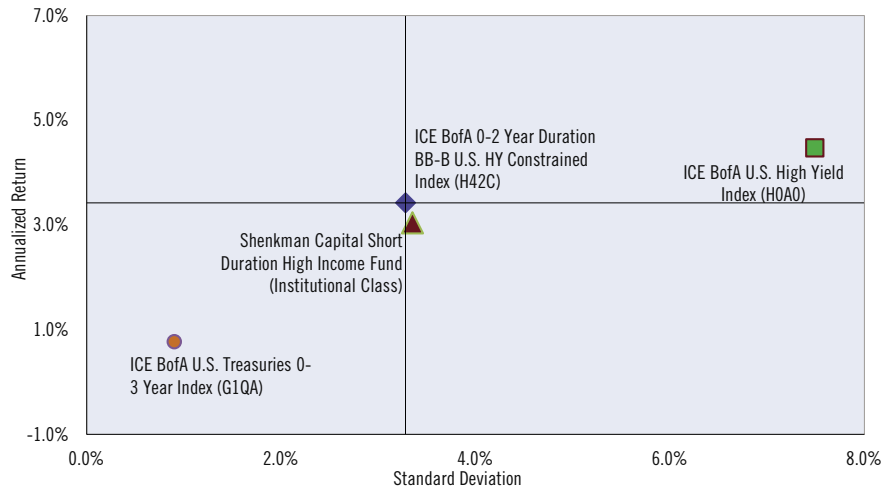
CREDIT QUALITY DISTRIBUTION²

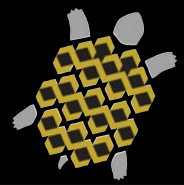

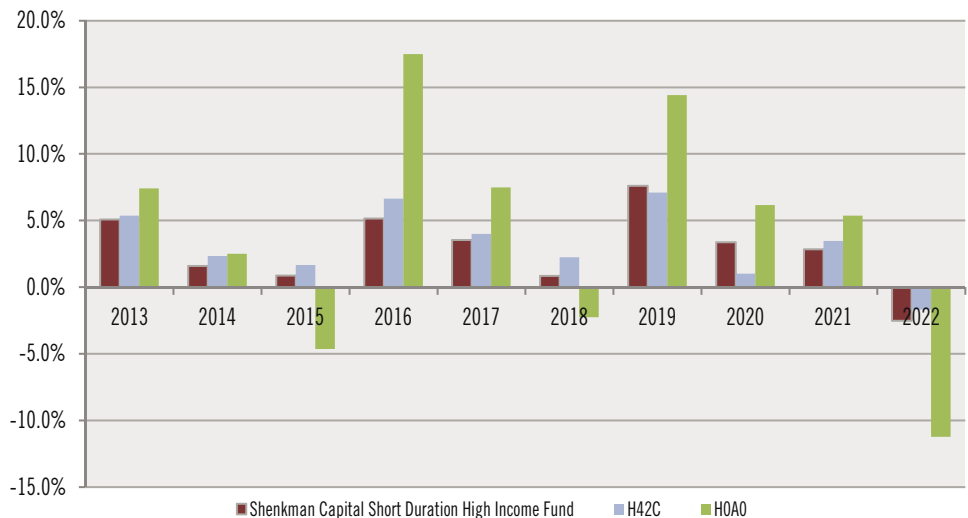

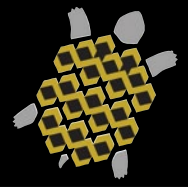

HIGH YIELD MARKET COMMENTARY

The high yield market had the strongest one month performance in two and a half years during January, as the ICE BofA US High Yield Index (HOAO, the "Index") posted a 3.92% return. The market performance, as measured by the HOAO, was helped by a rally in treasuries, but also appeared to benefit from technical flows into the asset class. The HOAO ended the month with a yield-to-worst of 8.17% and an option-adjusted-spread (OAS) of 430 basis points (bps); this represents a tightening of 79bps and 49bps, respectively for yield and spread. The higher-quality short duration segment of the high yield market also posted a positive return for the month, albeit constrained by its higher credit quality and shorter duration positioning. The ICE BofA 0-2 Year Duration BB-B U.S. HY Constrained Index (H42C) returned +1.85%, while shorter-date U.S. Treasuries lagged, delivering a monthly return of 0.57% as measured by the ICE BofA 0-3 Year U.S. Treasury Index's (G1QA).

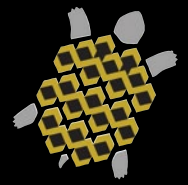
The rally had the appearance of a risk-on rally as CCC's outperformed with a return of 6.29%; the rating class had lagged the market in much of 2022. Additionally, longer duration tiers of the market rallied as the 6-8 year option-adjusted-duration (OAD) portion of the market returned 4.89%, while the 2 year and less OAD portion returned 2.05%. All sectors posted positive performance with Leisure, Gaming, and Travel posting the highest return of 4.78%. Utilities lagged the market with a return of 2.73%. Industrials, the largest sector, posted a return of 3.70%.

New issuance, which had been dormant in most of 2022, reopened in January with the strongest volumes in some weeks seen since 2021. While there were no defaults in all of 4Q 2022, there were a few in January; however, the default rate still sits around 1% (JPM), and upgrades started the year outpacing downgrades.

FUND COMMENTARY

The Shenkman Short Duration High Income Fund (the "Fund") posted its highest monthly performance of the past twelve months, albeit more tempered than the broader high yield market as a function of its higher quality and shorter duration positioning. Performance by credit rating echoed the broader high yield markets with lower ratings outperforming as the Fund's CCC rated credits posted the strongest returns and BB rated credits advanced at the slowest pace. On a sector basis, all sectors posted positive returns with Healthcare and Leisure, Gaming, Travel posting the strongest returns and Real Estate and Consumer Staples Discretionary posting the weakest contributions. The Fund's duration-to-worst moderated further to 1.8 years while the Fund's average bond price rose to \$97.8. The Fund's average final maturity ticked lower to 2.61 years, highlighting a conservative maturity profile which has helped limit the Fund's maximum duration potential. Corporate action activity decelerated to zero in the Fund for the month despite strength in the high yield primary market issuance. The Fund continues to seek compelling risk-adjusted return opportunities and strong credit selection as it remains mindful of liquidity risks and the interest rate outlook.

This first quarter, markets could oscillate as investors appear hopeful of a Fed pivot and wary of a potential recession. We currently believe the Fed will continue to hike rates through this quarter, albeit at a slower pace than last year. We also anticipate some increases in credit rating downgrades during the next several months. Meanwhile, investors appear to be searching for income and we believe the leverage credit market remains an attractive place to get income and will likely attract capital.

Option Adjusted Spread (OAS) is the measurement of the spread of a fixed-income security rate and the risk-free rate of return, which is adjusted to take into account an embedded option.

Par - The term at par means at face value. A bond, preferred stock, or other debt instruments may trade at par, below par, or above par.

Tenor refers to the length of time remaining before a financial contract expires.
