INVESTMENT PHILOSOPHY

The investment strategy is to seek to maximize risk-adjusted returns by investing in primarily first lien, senior secured, floating rate bank loans of non-investment grade (i.e., high yield) companies. The Shenkman Capital Floating Rate High Income Fund employs a conservative approach which focuses on principal preservation. Portfolios are well diversified across issue, issuer, and industry.

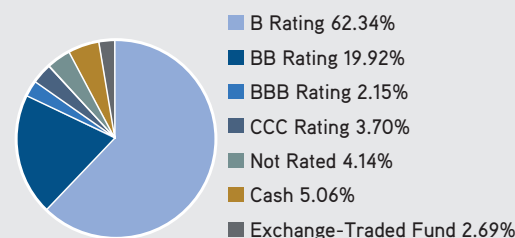

MONTHLY COMMENTARY

The leveraged loan market, as measured by the Morningstar LSTA US Leveraged Loan Index (the "Index"), returned 0.48% in the first quarter, marking the 12th consecutive quarterly gain for the asset class. Elevated coupons and robust collateralized loan obligation (CLO) formations continued to provide tailwinds for the asset class during the quarter, though impending tariff announcements spurred significant market volatility. For context, high yield bonds, investment grade bonds, and Treasuries, as measured by the ICE BofA US High Yield Index (H0A0), ICE BofA Corporate Index (C0A0), and the ICE BofA Current 10-year Treasury Index (GA10), posted returns of 0.95%, 2.36%, and 4.01%, respectively, while leveraged loans gained 0.48%.

Returns by rating showed a risk-off quality bias during the quarter as BBs and Bs gained 0.93% and 0.35%, respectively, while the riskier CCC & below rated cohort returned -0.93%. Liquid loans, as measured by the Morningstar LSTA US Leveraged Loan 100 Index, performed largely in-line with the broader Index during the quarter with a return of 0.45%. Of the 62 industries in the Index, 49 showed a positive return in the quarter. The top performing industries included Diversified Telecommunication Services, Textiles, Apparel & Luxury Goods, and Health Care Equipment & Supplies, while the performance laggards included Beverages, Building Products, and Household Products.

Primary leveraged loan market activity subsided in the first quarter to \$336.8 billion, following issuance of \$418.7 billion in the previous quarter. From a demand perspective, net CLO formations totaled \$44.8 billion in the quarter following \$50.7 billion in the previous quarter. Following outflows in both 2022 and 2023, retail demand for leveraged loans rebounded in 2024 with inflows of \$21.4 billion, which continued into the first quarter of 2025 as \$10.8 billion flowed into the asset class. Six loan issuers defaulted in the quarter affecting \$4.78 billion in loans. The trailing 12-month par-weighted default rate ended March at 1.24%, a 28 bps decrease from the previous quarter and 70 bps lower than one year ago, according to J.P. Morgan Research. For context, the historical leveraged loan default rate is approximately 3%. While the default rate has fallen over the last year, distressed exchange activity, including liability management exercises (LME), has remained elevated. Distressed exchange volume has accounted for nearly half of default/distressed volume last quarter, and the default rate including distressed exchanges ended the quarter at 3.86%.

After a year of Fed and election focus, investors are now contending with a new Trump administration and its nuances. The announcement of new tariffs on Canada and Mexico put the markets on edge in March, with an impending broader announcement focused on global partners looming in the closing weeks of the quarter. These fears came to a head on April 2nd with the announcement of significantly more extreme tariffs on virtually every country, well beyond the "reciprocal" measures the markets were anticipating. This broad and drastic increase in import costs took investors by surprise, spurring a sharp sell-off across most markets, causing economists to reevaluate forecasts for the balance of the year. Many market analysts are now calling for a U.S. recession later in the year, in addition to a rise in both inflation and unemployment. Fed Chairman Jerome Powell has left rates on pause as the central bank weighs the implications of this new economic environment and the ramifications on potentially higher inflation. While 2024 was heavily focused on actions from the Fed, we believe the coming months will continue to focus on administrative and legislative policy changes from the change in Administration. The balance of the year could be a crucial test of market resilience as consumers and corporations adapt to these rapid and significant changes, which are poised to arise at a rapid pace compared to the prior four years of relatively muted policy shifts. We continue to monitor developments across industries and the broader economy, seeking to assess the potential impact on the leveraged loan market. Given the current attractive all-in credit spreads, we believe the leveraged loan market presents compelling relative value opportunities, particularly given high current base rates. As we seek to proactively manage the portfolio and trade exposures across our global platform, our goal remains to safeguard against potential downside risks while concurrently optimizing returns.
