INVESTMENT PHILOSOPHY

The investment strategy is to seek to maximize risk-adjusted returns by investing in primarily first lien, senior secured, floating rate bank loans of non-investment grade (i.e., high yield) companies. The Shenkman Capital Floating Rate High Income Fund employs a conservative approach which focuses on principal preservation. Portfolios are well diversified across issue, issuer, and industry.

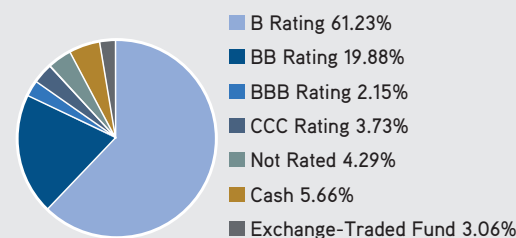

MONTHLY COMMENTARY

The leveraged loan market, as measured by the Morningstar LSTA US Leveraged Loan Index (the "Index"), returned -0.05% in April. High coupons and robust collateralized loan obligation (CLO) formations provided tailwinds for the asset class during the month despite the turbulence in the equity markets as investors digest a rapid flow of policy changes from the new Administration. For context, high yield bonds, investment grade bonds, and U.S. Treasuries, as measured by the ICE BofA U.S. High Yield Index (HOAO), ICE BofA Corporate Index (COAO), and ICE BofA Current 10-year Treasury Index (GA10), posted monthly returns of 0.00%, -0.03%, and 0.79%, respectively.

Returns by rating showed a quality bias in favor of higher-rated loans in April as BB and B rated loans returned 0.00% and 0.00%, respectively, while CCC & below rated loans returned -1.64%. Liquid loans, as measured by the Morningstar LSTA U.S. Leveraged Loan 100 Index, outperformed the Index in April with a return of 0.49%. The top performing industries in the Index included Building Products, Life Sciences Tools & Services, and Diversified Telecommunication Services, while the performance laggards included Beverages, Household Products, and Water Utilities. Of the 62 industries in the Index, 29 showed a positive return in April.

Primary leveraged loan market activity ground to a near halt in April with just \$6.2 billion coming to market following March issuance of \$56.7 billion. For context, the 2024 run rate was approximately \$110.6 billion per month. The use of proceeds continues to be dominated by refinancing and repricing activity, which represented over 80% of issuance year-to-date (27.9% and 53.2%, respectively). From a demand standpoint, gross CLO formations decreased 47% in April amid broad market turbulence. April gross CLO volume totaled \$25.4 billion (\$15.4 billion net of reset/refinancing) compared to March volume of \$47.9 billion (\$16.8 billion net of reset/refinancing). One loan issuer defaulted in April impacting \$1.0 billion in loans following three issuer defaults in the prior month affecting \$2.4 billion in par value. As a result, the J.P. Morgan 12-month par-weighted leveraged loan default rate decreased 1 bp to 1.23%, remaining below the historical average default rate of approximately 3%. The default rate has declined 29 basis points (bps) year-to-date. While traditional defaults, defined as a missed interest payment or bankruptcy, have been on the decline, distressed exchanges and liability management exercises (LMEs) have significantly increased. Including distressed exchanges, the default rate ended April at 3.98%, a 106 bps increase from a year earlier.

Investors around the globe are now contending with the reality of a second Trump Administration and its many nuances. The announcement of new tariffs on Canada and Mexico put the markets on edge in March, with an impending broader announcement focused on global partners looming in the closing weeks of the quarter. These fears came to a head on April 2 with the announcement of significantly more extreme tariffs on virtually every country, well beyond the "reciprocal" measures the markets were anticipating. This broad and drastic increase in import costs took investors by surprise, spurring a sharp sell-off across most markets, causing economists to reevaluate forecasts for the balance of the year. Further exhibiting the unpredictable nature of the current Administration, the tariffs were postponed days later prompting a sharp equity market recovery. Many market analysts who were previously calling for a U.S. recession later in the year following the initial tariff announcement have reversed course, though the residual tariffs may still result in slower GDP growth and weakening employment. Fed Chairman Jerome Powell has left rates on pause as the central bank weighs the implications of this new economic environment and the ramifications of potentially higher prices. While 2024 was heavily focused on actions from the Fed, we believe the coming months will continue to focus on administrative and legislative policy changes. The balance of the year could be a crucial test of market resilience as consumers and corporations adapt to these rapid and significant changes.

We continue to monitor developments across industries and the broader economy, seeking to assess the potential impact on the leveraged loan market. Given the current attractive all-in credit spreads, we believe the leveraged loan market presents compelling relative value opportunities, particularly given high current base rates. As we seek to proactively manage the portfolio and trade exposures across our global platform, our goal remains to safeguard against potential downside risks while concurrently optimizing returns.
